

Cookie Policy

MediCampus Europeo - MCE uses cookies to improve the quality of the MCE website and the related service, and to try to make the user's browsing experience meaningful.

When the user accesses the site, the MCE web server sends a cookie to his computer; this allows MCE to recognize the computer, but not the person who is using it. However, by associating the identification numbers contained in the cookies with other customer information, for example, when the user accesses the site, MCE can know that the information in the cookies refers to that user.

By continuing beyond this page and browsing the site, for example by accessing an area of the site or clicking on a link or image on the site itself, the user consents to the use of cookies in the manner defined by MCE and declares to have understood the this Cookie Policy which describes how the user can manage their choices and preferences regarding the use of cookies.

What are Cookies ?

Cookies are small text strings sent to your computer when you visit a website that store, and sometimes track, information about your use of the site. MCE does not use cookies for profiling activities of the user . The site uses technical and "third party" cookies.

The cookies used on the Site are those illustrated below:

A. Technical cookies

By "technical cookies" we mean, according to the cataloging provided by the Guarantor for the protection of Personal Data in general provision no. 229 of 8 May 2014 containing "Identification of simplified methods for providing information and obtaining consent for the use of cookies", navigation or session cookies, analytical cookies .

The use of these cookies does not require user consent. The technical cookies used by MCE are listed below:

A.1. Browsing or session cookies

These session cookies are necessary to allow the user to use the essential features of the site. Deactivating them could compromise the use of the site .

A.2. Analytical cookies

These cookies are also known as performance analysis cookies and are used to collect information on how users use the site, so that MCE can improve the quality of the site and the service.

The analytical cookies used by MCE do not collect information that could identify the user. All information collected by these cookies is aggregated and anonymous information used by MCE to:

- provide statistics on how it turns out used the site ;
- know through which website the user arrived at the site; And
- help MCE improve the site by measuring information about site usage and any errors that occur when users browse it.

B. Third party" cookies

By visiting a website you may receive cookies managed by different parties ("third parties") than the owner of the site visited. The management of information collected by "third parties" is governed by the relevant information.

"Third party" cookies allow third parties who use them to obtain more complete surveys and statistics on users' browsing habits. Deactivating these cookies can be done without any loss of functionality.

How the user can manage their cookie preferences

Some of the cookies used on the site are provided by MCE, while others are sent by third parties who provide services on behalf of MCE.

The user can choose to enable or disable cookies by changing the settings of your browser according to the instructions made available by the relevant suppliers. Since each browser has slightly different functions, check your browser's "help" menu to understand how to correctly change your cookie settings.

You can then change your browser settings so that cookies are deleted or not saved on your computer or mobile device without your explicit consent. At the following links you can better understand how to set your browser :
